**MOTION COURT DATES FOR CHIEF JUDGE CARLOTA M. BÖHM  
FOR SELF-SCHEDULED HEARINGS**

Pursuant to Local Rule 9013-5(a) and the General Procedures Established for Cases Assigned to Chief Judge Carlota M. Böhm (the “General Procedures”), the following list identifies the hearing dates and times to be used to self-schedule motions in Chapter 7, 11, 12, and 13 cases before Chief Judge Böhm for the months of *October 2021, November 2021, and December 2021.*

**Unless otherwise designated below or ordered, participation in all hearings before Judge Carlota M. Bohm beginning December 1, 2020, through the end of October 2021 shall be held by video through the use of the Zoom Video Conference Application (“Zoom”).** Please consult Section A “Procedures Applicable to All Cases” of the General Procedures on Chief Judge Böhm’s webpage for a list of matters that may not be self-scheduled. Any matter that is not eligible for self-scheduling will be set for hearing by the Court.

Counsel for a moving party for a self-scheduling matter shall select a date and time from the list below that satisfies all applicable notice and service requirements for the type of relief requested. **When self-scheduling a matter, be sure to use the appropriate form. For Zoom hearing dates, please use the Notice of Zoom Hearing and Response Deadline Regarding Motion, which is provided as an attachment to Judge Böhm’s posted Zoom Procedures. To the extent a hearing date is designated as telephonic, use Form CMB 301-T Notice of Hearing and Response Deadline Regarding Motion – Telephonic Procedures Effective March 16, 2020. Both forms can be found on Chief Judge Böhm’s Forms page on the Court’s website.**
