ORDER

The *Pittsburgh Division* of the Court is comprised of the "Pittsburgh Counties" and the "Johnstown Counties." The "Pittsburgh Counties" include Allegheny, Armstrong, Beaver, Butler, Fayette, Greene, Lawrence, Washington and Westmoreland. The "Johnstown Counties" include Bedford, Blair, Cambria, Indiana, Somerset and Clearfield. The *Erie Division* is comprised of the counties of Erie, Clarion, Elk, Jefferson, McKean, Warren, Crawford, Forest, Mercer, and Venango.

In light of the recent addition of Judge Gregory L. Taddonio to the Court, it is necessary to generally reassign cases within the Court by General Order superseding and replacing all prior case assignment Orders which are no longer of any force or effect. The following directive sets forth the current status of case assignments to each of the Judges of this Court and directs the Clerk, on a going forward basis, to maintain the distribution of bankruptcy cases among the Judges as specified in this Order.

AND NOW, this 29th day of July, 2013, in light of the foregoing, it is hereby ORDERED that, effective August 1, 2013:

- (1) All cases filed in the *Erie Division* of the Court are assigned to Judge Thomas P. Agresti.
- (2) All cases filed in the "Johnstown Counties" of the *Pittsburgh Division* are assigned to Judge Jeffery A. Deller.
- (3) Cases filed in the *Pittsburgh Division* of the Court will be promptly assigned on a random basis, except as otherwise noted, to the Judges of this Court in the following manner:
 - (a) Judges Agresti, Deller, Carlota M. Böhm and Taddonio are assigned an equal number of Chapter 11 cases filed in the "Pittsburgh Counties" of the *Pittsburgh Division* with Judges Agresti and Deller being given credit for the Chapter 11 cases assigned to each of them, respectively, in the *Erie Division* and "Johnstown Counties" of the *Pittsburgh Division*.
 - (b) Judge Böhm is assigned all Chapter 7 cases filed in the "Pittsburgh Counties" of the *Pittsburgh Division*.
 - (c) Chapter 13 cases filed in the "Pittsburgh Counties" of the *Pittsburgh Division* are assigned according to the following formula: Judge Taddonio will receive 63% of the cases; Judge Deller will receive 31% of the cases; and Judge Agresti will receive 6% of the cases.
 - (d) Judges Deller and Taddonio shall be assigned an equal number of Chapter 12 cases filed in the "Pittsburgh Counties" of the *Pittsburgh Division*.
 - (e) Judges Deller, Böhm and Taddonio will be assigned an equal number of Chapter 15 cases filed in the "Pittsburgh Counties" of the *Pittsburgh Division*.

(4) All prior General Orders involving assignment of cases are *VACATED*.
