**ORDER**

On March 18, 2005, General Order 2005-1 (the “Exemption Order”) was entered giving the Divorce Master for the Court of Common Pleas of Crawford County, Pennsylvania, an exemption from all fees related to Public Access to Court Electronic Records (PACER) effective April 1, 2005. A copy of the Exemption Order is attached hereto as Attachment A. In light of the changes to *The Guide to Judiciary Policy* that were enacted subsequent to the issuance of this Exemption Order indicating that courts should not exempt individuals or groups (such as local and state government agencies) that have the ability to pay the statutorily established fee, the United States Bankruptcy Court for the Western District of Pennsylvania Board of Judges have unanimously agreed to rescind the Exemption Order.

**AND NOW**, this 9<sup>th</sup> day of **January 2023**, it is hereby **ORDERED** that:

1. General Order 2005-1 giving the Divorce Master of the Court of Common Pleas of Crawford County, Pennsylvania, an exemption from all fees related to Public Access to Court Electronic Records is **VACATED**.
2. This Order shall remain in effect until further order of this Court.
