STANDING ORDER

- 1. The United States Bankruptcy Court for the Western District of Pennsylvania (the "Court") has deemed the new schedule of fees approved by the Judicial Council as necessary and appropriate and will adopt the following rate increases for the delivery of transcripts (see Attachment A).
- 2. The Court will also revise its transcript category names to adopt those approved by the Judicial Conference.
 - 3. This Order supersedes General Order 2007-4 attached hereto as Attachment B.
 - 4. This Order shall remain in effect until further order of this Court.
