ORDER

On May 21, 2002, General Order 2002-4 (the “Exemption Order”) was entered giving The Family Division, Court of Common Pleas of Allegheny County, Fifth Judicial District of Pennsylvania, an exemption from all fees related to Public Access to Court Electronic Records (PACER) effective June 1, 2002. A copy of the Exemption Order is attached hereto as Attachment A. In light of the changes to *The Guide to Judiciary Policy* that were enacted subsequent to the issuance of this Exemption Order indicating that courts should not exempt individuals or groups (such as local and state government agencies) that have the ability to pay the statutorily established fee, the United States Bankruptcy Court for the Western District of Pennsylvania Board of Judges have unanimously agreed to rescind the Exemption Order.

AND NOW, this **9th** day of **January 2023**, it is hereby **ORDERED** that:

1. General Order 2002-4 giving The Family Division, Court of Common Pleas of Allegheny County, Fifth Judicial District of Pennsylvania, an exemption from all fees related to Public Access to Court Electronic Records is **VACATED as of March 15, 2023**.
2. This Order shall remain in effect until further order of this Court.
